Combat Zone Tax Exclusion, or CZTE, allows military members to exclude all or a portion of pay and entitlements earned while serving in designated combat areas from tax liabilities Qualification

Civilians Serving in Combat Zones

For members of the US Armed Forces who serve in a combat zone, the following amounts may be excluded from their income: 3! Active duty pay earned in any month during service in a combat zone! Imminent danger/hostile fire pay! A reenlistment bonus (when the voluntary extension or reenlistment occurs in a month served in a combat zone)!
